## THINGS TO BRING

- Bible
- Note-taking: pen and notepad
- Face Mask & Gloves (not mandatory)
- Spending Money for Snack Shop and Off-campus activities
- Appropriate clothing (see *DRESS CODE*)
- Appropriate swimwear (see *DRESS CODE*)
- Active outdoor activity clothing
- Personal hygiene toiletries
- Towel/Toothbrush/Toothpaste
- Sunscreen/Sun Protection
- Linens for a twin bed or sleeping bag & pillow

## THINGS NOT TO BRING

- Anything promoting non-Christian groups, books, magazines or music are not allowed.
- Electronic devices such as iPads, iPods, laptops, video game consoles, portable video games, or DVD players.
- Any weapons of any kind, fireworks or drugs. (ONLY prescribed medication as noted on medical form is permitted.)
- Any clothing with ungodly values, vulgar art or language, racial slurs, acronyms, political influence, exposing stomach, cleavage or undergarments is not allowed.

## DRESS CODE

We depend on the parents to help their campers determine appropriately modest clothing. The dress code will be enforced by camp staff. While the style seems to constantly change, our standards for modesty have not. Modesty is important and, because of this, we have a few rules concerning our dress code:

- All tops and shirts should cover at least the beltline (when arms are raised) and must be at least 3 fingers wide at the shoulder. No halters or spaghetti straps. Sheer shirts must have a camp appropriate shirt worn underneath.
- Shorts should have AT LEAST A 4" INSEAM and skirts should be knee-length.
- Skin-tight clothing (tops, spandex, yoga pants, tight jeans, etc.), halter tops, and/or revealing clothing are inappropriate for camp and need to be left at home. Young ladies, do not bring any shirts/tops that reveal cleavage.
- During swim time, appropriate swimwear must be worn. Guys, swim trunks must be of modest length. Girls, swimsuits should be a one piece, tank-ini, or t-shirt worn over a swimsuit.

Parents, be conscious of the length and fit of ALL clothing. Please discuss the dress code with your youth BEFORE packing for camp and make sure they completely understand our dress code. It is your primary responsibility.

The Camp Directors have the final say on what is appropriate and acceptable clothing at Camp and may ask a camper to change if inappropriate clothes are worn.

# RELEASE OF LIABILITY

PLEASE READ CAREFULLY

IN CONSIDERATION OF INTERNATIONAL BIBLE CENTER (IBC), FURNISHING FACILITIES, SERVICES, ACCOMMODATIONS AND/OR EQUIPMENT TO OUR YOUTH GROUP AT ELEVATE SUMMER CAMP JUNE 26-30, 2023, WE AGREE:

WE FULLY UNDERSTAND AND ACKNOWLEDGE THAT RISKS, DANGERS AND HAZARDS MAY EXIST IN OUR USE OF FACILITIES, SERVICES, ACCOMMODATIONS AND/OR EQUIPMENT AT IBC; THAT OUR PARTICIPATION IN THE USE OF SAID FACILITIES, SERVICES, ACCOMMODATIONS AND/OR EQUIPMENT MAY RESULT IN INJURY OR ILLNESS INCLUDING, BUT NOT LIMITED TO BODILY INJURY, DISEASE, STRAINS, FRACTURES, PARTIAL AND/OR TOTAL PARALYSIS OR OTHER AILMENTS THAT COULD CAUSE SERIOUS DISABILITY OR EVEN DEATH; THAT THESE RISKS AND DANGERS MAY BE CAUSED BY THE NEGLIGENCE OF THE AGENTS, OFFICERS OR EMPLOYEES OF IBC, THE NEGLIGENCE OF THE PARTICIPANTS, THE NEGLIGENCE OF OTHERS, ACCIDENTS, BREACH OF CONTRACT, THE FORCES OF NATURE OR OTHER CAUSES. RISKS AND DANGERS MAY ARISE FROM FORESEEABLE OR UNFORESEEABLE CAUSES INCLUDING, BUT NOT LIMITED TO, EMPLOYEE DECISION MAKING, INCLUDING THAT AN EMPLOYEE MAY MISJUDGE TERRAIN, WEATHER, OFF-SITE LOCATION DANGERS, OR ANY OTHER DANGERS NOT MENTIONED; AND THAT BY OUR PARTICIPATION IN THE USE OF ANY RESPONSIBILITY FOR LOSSES AND/OR DAMAGES, WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR OTHER CONDUCT OF THE AGENTS, OFFICERS, OR EMPLOYEES OF IBC OR BY ANY OTHER PERSON OR ENTITY. WE, ON BEHALF OF OUR YOUTH GROUP, DO HEREBY VOLUNTARILY AGREE TO RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, DEFEND AND INDEMNIFY IBC AND ITS AGENTS, OFFICERS AND EMPLOYEES FROM ANY AND ALL CLAIMS, ACTIONS OR LOSSES FOR BODILY INJURY, PROPERTY DAMAGE, WRONGFUL DEATH, LOSS OF SERVICES OR OTHERWISE WHICH MAY ARISE OUT OF OUR PARTICIPATION IN THE USE OF ANY FACILITIES, SERVICES, ACCOMMODATIONS AND/OR EQUIPMENT AT IBC. WE SPECIFICALLY UNDERSTAND THAT WE ARE RELEASING, DISCHARGING AND WAIVING ANY CLAIMS OR ACTIONS THAT WE MAY HAVE PRESENTLY OR IN THE FUTURE FOR THE NEGLIGENT ACTS OR OTHER CONDUCT BY THE AGENTS, OFFICERS OR EMPLOYEES OF IBC. THE VENUE OF ANY DISPUTE THAT MAY ARISE OUT OF THIS AGREEMENT OR OTHERWISE BETWEEN THE PARTIES TO WHICH IBC OR ITS AGENTS IS A PARTY SHALL BE EITHER THROUGH INDEPENDENT ARBITRATION OR THROUGH THE COURT SYSTEM IN BEXAR COUNTY, TEXAS. WE UNDERSTAND THAT WE ARE ASSUMING RESPONSIBILITY FOR ALL THE PARTICIPANTS FROM OUR GROUP IN ANY MATTER STIPULATED OR INFERRED ABOVE.

WE HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS OUR INTENTION TO EXEMPT AND RELIEVE IBC FROM LIABILITY FROM PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.

YOUR SIGNATURE BELOW INDICATES THAT YOU FULLY UNDERSTAND AND GIVE PERMISSION TO MEDICAL, SURGICAL AND NURSING SERVICES, WHICH MAY BE NECESSARY, AND WHICH ONLY WILL BE GIVEN BY APPROVED PHYSICIANS AND/OR NURSES. WE WILL CONTINUE TO MONITOR AND ADJUST OUR HEALTH AND SAFETY PROCEDURES THAT ARE ALREADY IN PLACE. WE ARE PREPARING TO OPERATE WITH VIGILANCE AND PRECAUTION. OUR CAMP WILL CONTINUE AS PLANNED AND WE ARE PRAYING THAT ILLNESS OR VIRUS WILL NOT HINDER WHAT GOD PLANS TO ACCOMPLISH IN THE HEARTS AND MINDS OF THE YOUTH LEADERSHIP, ELEVATE STAFF AND STUDENTS.

INCLUDED IN THIS SUMMER'S PROCEDURES:

PRE-CAMP SCREENING OF CAMPERS AND LEADERS FOR SICKNESS THROUGH SIGNED AFFIDAVIT, TEMPERATURES TAKEN/RECORDED AT CHECK IN, COVERING OF MOUTH AND NOSE WHEN SNEEZING WITH TISSUE OR COUGHING INTO ELBOW, WASHING HANDS FREQUENTLY- HAND SANITIZERS AVAILABLE IN STRATEGIC AREAS, FREQUENT DISINFECTING OF OBJECTS AND SURFACES, AVOID TOUCHING EYES, NOSE, MOUTH, AND FACE.

TEMPERATURES WILL BE TAKEN WITH A HEAT SENSITIVE HAND-HELD TOUCH TO FOREHEAD PRIOR TO LEAVING VEHICLE.
